19 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-
20 entitled proceedings that the following matters are true:

21 **PARTIES**

22 1. Benjamin Bodea (Complainant) is the Executive Officer of the Acupuncture Board
23 (Board). He brought this action solely in his official capacity and is represented in this matter by
24 Xavier Becerra, Attorney General of the State of California, by Jonathan Nguyen, Deputy
25 Attorney General.

26 2. Susan Shriver Rodnunsky, L.Ac. (Respondent) is representing herself in this
27 proceeding and has chosen not to exercise her right to be represented by counsel.

1 4. If Respondent ever files an application for licensure or a petition for reinstatement in
2 the State of California, the Board shall treat it as a petition for reinstatement of a revoked license.
3 Respondent must comply with all the laws, regulations and procedures for reinstatement of a
4 revoked license in effect at the time the petition is filed, and all of the charges and allegations
5 contained in Petition to Revoke Probation No. D1-2017-153 shall be deemed to be true, correct
6 and admitted by Respondent when the Board determines whether to grant or deny the petition.

7 5. Respondent shall pay the agency its costs of investigation and enforcement in the
8 amount of \$3542.50 prior to issuance of a new or reinstated license.

9 6. If Respondent should ever apply or reapply for a new license or certification, or
10 petition for reinstatement of a license, by any other health care licensing agency in the State of
11 California, all of the charges and allegations contained in Petition to Revoke Probation, No. D1-
12 2017-153 shall be deemed to be true, correct, and admitted by Respondent for the purpose of any
13 Statement of Issues or any other proceeding seeking to deny or restrict licensure.

14 ACCEPTANCE

15 I have carefully read the Stipulated Surrender of License and Order. I understand the
16 stipulation and the effect it will have on my Acupuncturist License. I enter into this Stipulated
17 Surrender of License and Order voluntarily, knowingly, and intelligently, and agree to be bound
18 by the Decision and Order of the Acupuncture Board.
