**STIPULATED SETTLEMENT AND  
DISCIPLINARY ORDER**

19 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-  
20 entitled proceedings that the following matters are true:

21 PARTIES

22 1. Janelle Wedge (Complainant) is the Executive Officer of the Acupuncture Board of  
23 California. She brought this action solely in her official capacity and is represented in this matter  
24 by Edmund G. Brown Jr., Attorney General of the State of California, by Abraham M. Levy,  
25 Deputy Attorney General.

26 2. Respondent TIMOTHY WALSH, L.AC. (Respondent) is represented in this  
27 proceeding by attorney John Mulvana, Esq., whose address is 100 Pacifica, Suite 220, Irvine, CA  
28 92618.

1 3. On or about June 5, 2001, the Board issued Acupuncture License Number AC 7904 to  
2 Timothy Walsh ("Respondent"). The license is current, valid and on inactive status.

3 JURISDICTION

4 4. First Amended Accusation No. 1A-2009-35 was filed before the Acupuncture Board  
5 of California (Board), Department of Consumer Affairs, and is currently pending against  
6 Respondent. The First Amended Accusation and all other statutorily required documents were  
7 properly served on Respondent on 1A-2009-35. Respondent timely filed his Notice of Defense  
8 contesting the allegations contained in Accusation No. 1A-2009-35. A copy of First Amended  
9 Accusation No. 1A-2009-35 is attached as exhibit A and incorporated herein by reference.

10 ADVISEMENT AND WAIVERS

11 5. Respondent has carefully read, fully discussed with counsel, and understands the  
12 charges and allegations in First Amended Accusation No. 1A-2009-35. Respondent has also  
13 carefully read, fully discussed with counsel, and understands the effects of this Stipulated  
14 Settlement and Disciplinary Order.

15 6. Respondent is fully aware of his legal rights in this matter, including the right to a  
16 hearing on the charges and allegations in the Accusation; the right to be represented by counsel at  
17 his own expense; the right to confront and cross-examine the witnesses against him; the right to  
18 present evidence and to testify on his own behalf; the right to the issuance of subpoenas to compel  
19 the attendance of witnesses and the production of documents; the right to reconsideration and  
20 court review of an adverse decision; and all other rights accorded by the California  
21 Administrative Procedure Act and other applicable laws.

22 7. Respondent voluntarily, knowingly, and intelligently waives and gives up each and  
23 every right set forth above.

24 CULPABILITY

25 8. For the purpose of resolving the allegations in First Amended Accusation No. 1A-  
26 2009-35 without the expense and uncertainty of further proceedings, Respondent agrees that, at a  
27 hearing, Complainant could present a *prima facie* case establishing the factual basis for the charge  
28 of unprofessional conduct as alleged in the First Cause for Discipline in First Amended

1 Accusation No. 1A-2009-35. Respondent, further, admits to the allegations detailed in the Second  
2 Cause for Discipline in the First Amended Accusation No. 1A-2009-35, failure to register his  
3 place of business, the Hall Center, with the Board. Respondent hereby gives up his right to  
4 contest those charges.

5 9. Respondent understands and agrees that the charges and allegations in First Amended  
6 Accusation No. 1A-2009-35, if proven at a hearing, constitute cause for imposing discipline upon  
7 his Acupuncture License Number AC 7904. Respondent agrees that his Certificate is subject to  
8 such discipline and agrees to be bound by the Board's imposition of same as set forth in the  
9 Disciplinary Order below.

10 10. Respondent further agrees that if he ever petitions for early termination or  
11 modification of probation, or reinstatement of his license, or if he ever petitions for revocation of  
12 probation, all of the charges and allegations contained in the First Amended Accusation identified  
13 above shall be deemed true, correct and fully admitted by Respondent for purposes of that  
14 proceeding or any other licensing proceeding involving respondent in the State of California or  
15 elsewhere.

#### 16 RESERVATION

17 11. The admissions made by Respondent herein are only for the purposes of this  
18 proceeding, or any other proceedings in which the Acupuncture Board of California or other  
19 professional licensing agency is involved, and shall not be admissible in any other criminal or  
20 civil proceeding.

#### 21 CONTINGENCY

22 12. This stipulation shall be subject to approval by the Acupuncture Board of California.  
23 Respondent understands and agrees that counsel for Complainant and the staff of the Acupuncture  
24 Board of California may communicate directly with the Board regarding this stipulation and  
25 settlement, without notice to or participation by Respondent or his counsel. By signing the  
26 stipulation, Respondent understands and agrees that he may not withdraw his agreement or seek  
27 to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails  
28 to adopt this stipulation as its Decision and Order, the Stipulated Settlement and Disciplinary

1 Order shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal  
2 action between the parties, and the Board shall not be disqualified from further action by having  
3 considered this matter.

4 13. The parties understand and agree that facsimile copies of this Stipulated Settlement  
5 and Disciplinary Order, including facsimile signatures thereto, shall have the same force and  
6 effect as the originals.

7 14. In consideration of the foregoing admissions and stipulations, the parties agree that  
8 the Board may, without further notice or formal proceeding, issue and enter the following  
9 Disciplinary Order:

10 **DISCIPLINARY ORDER**

11 IT IS HEREBY ORDERED that Acupuncture License Number AC 7904 issued to  
12 Timothy Walsh (Respondent) is revoked. However, the revocation is stayed and Respondent is  
13 placed on probation for two (2) years on the following terms and conditions.

14 1. **COURSEWORK** Respondent shall take and successfully complete an ethics  
15 course in Illinois subject to Board approval. All costs of the coursework shall be borne by the  
16 respondent.

17 2. **OBEY ALL LAWS** Respondent shall obey all federal, state and local laws and  
18 all regulations governing the practice of acupuncture in California. A full and detailed account of  
19 any and all violations of law shall be reported by the respondent to the Board in writing within  
20 seventy-two (72) hours of occurrence.

21 3. **QUARTERLY REPORTS** Respondent shall submit quarterly declarations under  
22 penalty of perjury on forms provided by the Board, stating whether there has been compliance  
23 with all the conditions of probation.

24 4. **SURVEILLANCE PROGRAM** Respondent shall comply with the Board's  
25 probation surveillance program and shall, upon reasonable notice, report to the assigned  
26 investigative district office. Respondent shall contact the assigned probation surveillance monitor  
27 regarding any questions specific to the probation order. Respondent shall not have any unsolicited  
28 or unapproved contact with 1) victims or complainants associated with the case; 2) Board

1 members or members of its staff; or 3) persons serving the Board as expert examiners.

2 5. INTERVIEW WITH THE BOARD OR ITS DESIGNEE Respondent shall  
3 appear in person for interviews with the Board or its designee upon request at various intervals  
4 and with reasonable notice.

5 6. CHANGES OF EMPLOYMENT Respondent shall notify the Board in writing,  
6 through the assigned probation surveillance compliance officer of any and all changes of  
7 employment, location and address within 30 days of such change.

8 7. EMPLOYMENT AND SUPERVISION OF TRAINEES Respondent shall not  
9 employ or supervise or apply to employ or supervise acupuncture trainees during the course of  
10 this probation. Respondent shall terminate any such supervisory relationship in existence on the  
11 effective date of this probation.

12 8. COST RECOVERY Respondent shall pay to the Board its costs of investigation  
13 and enforcement in the amount of \$6500.00.

14 9. VIOLATION OF PROBATION If respondent violates probation in any respect,  
15 the Board may, after giving respondent notice and the opportunity to be heard, revoke probation  
16 and carry out the disciplinary order that was stated. If an accusation or petition to revoke  
17 probation is filed against respondent during probation, the Board shall have continuing  
18 jurisdiction until the matter is final, and the period of probation shall be extended until the matter  
19 is final. No petition for modification or termination of probation shall be considered while there is  
20 an accusation or petition to revoke probation pending against respondent.

21 10. COMPLETION OF PROBATION Upon successful completion of probation,  
22 respondent's license will be fully restored.

**FIRST AMENDED ACCUSATION**

17 **PARTIES**

18  
19 1. Janelle Wedge ("Complainant") brings this Accusation solely in her official capacity  
20 as the Executive Director of the Acupuncture Board of California ("Board"), Department of  
21 Consumer Affairs. This Accusation is brought before the Board under the authority of the  
22 following laws. All section references are to the Business and Professions Code unless otherwise  
23 indicated.

24 2. On or about June 5, 2001, the Board issued Acupuncture License Number AC  
25 7904 to Timothy Walsh ("Respondent"). The license is current, valid and on inactive status.

26 ///

JURISDICTION

1  
2           3.     This Accusation is brought before the Acupuncture Board, Department of Consumer  
3 Affairs, under the authority of the following laws. All section references are to the Business and  
4 Professions Code unless otherwise indicated.

5           4.     This Accusation is brought before the Board under the authority of the following  
6 laws. All section references are to the Business and Professions Code ("Code") unless otherwise  
7 indicated.

8           5.     Section 480(c) of the Code states:

9           "(c) A board may deny a license regulated by this code on the ground that the application  
10 knowingly made a false statement of fact required to be revealed in the application for such  
11 license."

12          6.     Section 498 of the Code states:

13          "A board may revoke, suspend, or otherwise restrict a license on the ground that the  
14 licensee secured the license by fraud, deceit, or knowing misrepresentation of a material fact or  
15 by knowingly omitting to state a material fact."

16          7.     Section 4937 of the Code states:

17          "An acupuncturist's license authorizes the holder thereof:

18          "(a) To engage in the practice of acupuncture.

19          "(b) To perform or prescribe the use of Asian massage, acupressure, breathing techniques,  
20 exercise, heat, cold, magnets, nutrition, diet, herbs, plant, animal, and mineral products, and  
21 dietary supplements to promote, maintain, and restore health. Nothing in this section prohibits  
22 any person who does not possess an acupuncturist's license or another license as a healing arts  
23 practitioner from performing, or prescribing the use of any modality listed in this subdivision.

24          "(c) For purposes of this section, a "magnet" means a mineral or metal that produces a  
25 magnetic field without the application of an electric current.

26          "(d) For purposes of this section, "plant, animal, and mineral products" means naturally  
27 occurring substances of plant, animal, or mineral origin, except that it does not include synthetic  
28 compounds, controlled substances or dangerous drugs as defined in Sections 4021 and 4022, or a

1 controlled substance listed in Chapter 2 (commencing with Section 11053) of Division 10 of the  
2 Health and Safety Code.

3 “(e) For purposes of this section, “dietary supplement” has the same meaning as defined  
4 in subsection (ff) of Section 321 of Title 21 of the United States Code, except that dietary  
5 supplement does not include controlled substances or dangerous drugs as defined in Section 4021  
6 or 4022, or a controlled substance listed in Chapter 2 (commencing with Section 11053) of  
7 Division 10 of the Health and Safety Code.”

8 8. Section 4955 of the Code states, *inter alia*:

9 “The board may deny, suspend, or revoke, or impose probationary conditions upon, the  
10 license of any acupuncturist if he or she is guilty of unprofessional conduct.

11 “Unprofessional conduct shall include, but not be limited to, the following:

12 “(a) Using or possessing any controlled substance as defined in Division 10 (commencing  
13 with Section 11000) of the Health and Safety Code, or dangerous drug or alcoholic beverage to an  
14 extent or in a manner dangerous to himself or herself, or to any other person, or to the public, and  
15 to an extent that the use impairs his or her ability to engage in the practice of acupuncture with  
16 safety to the public.

17 “(b) Conviction of a crime substantially related to the qualifications, functions, or duties  
18 of an acupuncturist, the record of conviction being conclusive evidence thereof.

19 “(c) False or misleading advertising.

20 “(d) Aiding or abetting in, or violating or conspiring in, directly or indirectly, the  
21 violation of the terms of this chapter or any regulation adopted by the board pursuant to this  
22 chapter.

23 “(e) Except for good cause, the knowing failure to protect patients by failing to follow  
24 infection control guidelines of the board, thereby risking transmission of blood-borne infectious  
25 diseases from licensee to patient, from patient to patient, and from patient to licensee. In  
26 administering this subdivision, the board shall consider referencing the standards, regulations, and  
27 guidelines of the State Department of Health Services developed pursuant to Section 1250.11 of  
28 the Health and Safety Code and the standards, regulations, and guidelines pursuant to the

1 California Occupational Safety and Health Act of 1973 (Part 1 (commencing with Section 6300)  
2 of Division 5 of the Labor Code) for preventing the transmission of HIV, hepatitis B, and other  
3 blood-borne pathogens in health care settings. As necessary, the board shall consult with the  
4 Medical Board of California, the California Board of Podiatric Medicine, the Dental Board of  
5 California, the Board of Registered Nursing, and the Board of Vocational Nursing and Psychiatric  
6 Technicians, to encourage appropriate consistency in the implementation of this subdivision.  
7 The board shall seek to ensure that licensees are informed of the responsibility of licensees and  
8 others to follow infection control guidelines, and of the most recent scientifically recognized  
9 safeguards for minimizing the risk of transmission of blood-borne infectious diseases.

10 “(f) The use of threats or harassment against any patient or licensee for providing evidence  
11 in a disciplinary action, other legal action, or in an investigation contemplating a disciplinary  
12 action or other legal action.

13 “(g) Discharging an employee primarily for attempting to comply with the terms of this  
14 chapter.

15 “(h) Disciplinary action taken by any public agency for any act substantially related to the  
16 qualifications, functions, or duties of an acupuncturist or any professional health care licensee.

17 “(i) Any action or conduct that would have warranted the denial of the acupuncture  
18 license.

19 “(j) The violation of any law or local ordinance on an acupuncturist's business premises  
20 by an acupuncturist's employee or a person who is working under the acupuncturist's professional  
21 license or business permit, that is substantially related to the qualifications, functions, or duties of  
22 an acupuncturist. These violations shall subject the acupuncturist who employed the individuals,  
23 or under whose acupuncturist license the employee is working, to disciplinary action.

24 “(k) The abandonment of a patient by the licentiate without written notice to the patient  
25 that treatment is to be discontinued and before the patient has had a reasonable opportunity to  
26 secure the services of another practitioner.

27 “(l) the failure to notify the board of the use of any false, assumed, or fictitious name  
28 other than the name under which he or she is licensed as an individual to practice acupuncture.”

1           9.           Section 4955.2 reads as follows:

2           “The board may deny, suspend, revoke, or impose probationary conditions upon the license  
3 of any acupuncturist if he or she is guilty of committing any one of the following:

4           “(a) Gross negligence.

5           “(b) Repeated negligent acts.

6           “(c) Incompetence.”

7           10.          Section 4961 reads as follows:

8           “(a) Every person who is now or hereafter licensed to practice acupuncture in this state  
9 shall register, on forms prescribed by the Acupuncture Board, his or her place of practice, or, if he  
10 or she has more than one place of practice, all of the places of practice. If the licensee has no  
11 place of practice, he or she shall notify the board of that fact. A person licensed by the board shall  
12 register within 30 days after the date of his or her licensure.

13           “(b) An acupuncturist licensee shall post his or her license in a conspicuous location in his  
14 or her place of practice at all times. If an acupuncturist has more than one place of practice, he or  
15 she shall obtain from the board a duplicate license for each additional location and post the  
16 duplicate license at each location.

17           “(c) Any licensee that changes the location of his or her place of practice shall register  
18 each change within 30 days of making that change. In the event a licensee fails to notify the board  
19 of any change in the address of a place of practice within the time prescribed by this section, the  
20 board may deny renewal of licensure. An applicant for renewal of licensure shall specify in his or  
21 her application whether or not there has been a change in the location of his or her place of  
22 practice and, if so, the date of that change. The board may accept that statement as evidence of the  
23 change of address.”

24           11.          Section 125.3 of the Code provides,

25           “(a) Except as otherwise provided by law, in any order issued in resolution of a disciplinary  
26 proceeding before any board within the department or before the Osteopathic Medical Board upon  
27 request of the entity bringing the proceedings, the administrative law judge may direct a licentiate  
28

1 found to have committed a violation or violations of the licensing act to pay a sum not to exceed the  
2 reasonable costs of the investigation and enforcement of the case.

3       "(b) In the case of a disciplined licentiate that is a corporation or a partnership, the order may  
4 be made against the licensed corporate entity or licensed partnership.

5       "(c) A certified copy of the actual costs, or a good faith estimate of costs where actual costs  
6 are not available, signed by the entity bringing the proceeding or its designated representative shall be  
7 prima facie evidence of reasonable costs of investigation and prosecution of the case. The costs shall  
8 include the amount of investigative and enforcement costs up to the date of the hearing, including, but  
9 not limited to, charges imposed by the Attorney General.

10       "(d) The administrative law judge shall make a proposed finding of the amount of reasonable  
11 costs of investigation and prosecution of the case when requested pursuant to subdivision (a). The  
12 finding of the administrative law judge with regard to costs shall not be reviewable by the board to  
13 increase the cost award. The board may reduce or eliminate the cost award, or remand to the  
14 administrative law judge if the proposed decision fails to make a finding on costs requested pursuant  
15 to subdivision (a).

16       "(e) If an order for recovery of costs is made and timely payment is not made as directed in  
17 the board's decision, the board may enforce the order for repayment in any appropriate county. This  
18 right of enforcement shall be in addition to any other rights the board may have as to any licentiate to  
19 pay costs.

20       "(f) In any action for recovery of costs, proof of the board's decision shall be conclusive proof  
21 of the validity of the order of payment and the terms for payment.

22       "(g)(l) Except as provided in paragraph (2), the board shall not renew or reinstate the license  
23 of any licentiate who has failed to pay all of the costs ordered under this section.

24 (2) Notwithstanding paragraph (1), the board may, in its discretion, conditionally renew or reinstate  
25 for a maximum of one year the license of any licentiate who demonstrates financial hardship and who  
26 enters into a formal agreement with the board to reimburse the board within that one-year period for  
27 the unpaid costs.

28

1 (h) All costs recovered under this section shall be considered a reimbursement for costs  
2 incurred and shall be deposited in the fund of the board recovering the costs to be available upon  
3 appropriation by the Legislature.

4 (i) Nothing in this section shall preclude a board from including the recovery of the costs of  
5 investigation and enforcement of a case in any stipulated settlement. "

6 **FACTUAL SUMMARY**

7 12. Complainant summarizes the facts and circumstances as follows:

8 13. Patient M.N. initially presented to Hall Center, Inc on or about March 24, 2007  
9 and March 27, 2007 where Respondent was employed. Hall Center is a wellness facility that  
10 "helps their clients rejuvenate to regain and maintain their vitality, energy and well-being. Our  
11 approach to health is guided by the principles of Functional Medicine - a revolutionary science-  
12 based practice of medicine. Our practitioners identify and alter hormone imbalances,  
13 inflammation, adrenal stress, metabolic problems and detoxification problems. As we alter these  
14 processes, we actually rejuvenate and increase energy, leaving the body balanced and healthy."  
15 <http://www.thehallcenter.com/about/>.

16 14. Respondent worked at Hall Center from November 2005 to June 2009.

17 15. On March 24, 2007 and March 27, 2007 employees at this facility took M.N.'s  
18 health history. Though acupuncture was not specifically recommended, the employee practitioner  
19 stated in M.N.'s records that the patient should follow-up with Respondent with for a six (6) week  
20 "detox treatment," the practitioner further commented, "patient is toxic" under a chart section  
21 captioned "Other Concerns." Patient was further reported to have "toxic exposure" to arsenic and  
22 poisonous sprays. She reported several past surgeries including cosmetic eye surgeries, nose  
23 surgeries, Lasik eye surgery. The intake form also reported that M.N. suffered from dry eyes.

24 17. On or about August 17, 2007 M.N. initially treated with Respondent. She  
25 complained of lost fat from chest, breast, Reynaud's, hair loss, breathing problems, bladder  
26 infection, thin skin, pain in back of tongue, as documented in chart notes written by Respondent.

1           18.       Respondent recommended that laser treatment be applied to her legs, body and  
2 eyes in conjunction with her acupuncture treatment. Respondent told M.N. that this laser  
3 treatment stimulates the growth of healthy cells and assured her regarding the safety of this  
4 procedure. Specifically, Respondent employed an LLLT/Class I laser, manufactured by 2035,  
5 Inc.<sup>1</sup> The specific device he used was a wand which he would waive over the patient's body parts.

6           19.       In M.N.'s chart note dated October 12, 2007 Respondent recorded a message from  
7 M.N. to remind Respondent to bring his "Laser" for her appointment on October 13, 2007. In his  
8 note Respondent stated, "ok." In his October 13, 2007 medical chart, Respondent recorded her  
9 subjective complaints as "a.a. powder – Irritated stomach and mouth; Biopsy for Sjogrens  
10 (negative); fat tissue is disappearing." He noted her "pulse" as "thin on lt., very weak on rt." He  
11 circled various areas of a tongue diagram on the chart. Under the caption "Protocol" Respondent  
12 checked off a box for "Laser" and wrote "breast, eyes, nose, mouth." Under the caption "Follow-  
13 up Schedule" Respondent checked off "other" and wrote "going to see a toxicologist."

14           20.       Respondent administered laser treatments to M.N.'s legs, body, and eyes. On or  
15 about October 17, 2007 M.N. reported inflammation to her internal medicine doctor in your eyes  
16 and blurred vision.

17           21.       Respondent saw M.N. on November 19, 2007. He charted, for this date, that M.N.  
18 reported left eye "blurriness after (laser treatment) of eyes." He noted, " (eyes) inflamed  
19 imme(diatly) after laser" and (M.N.) thinks it is the surface of the eye. Respondent finally noted  
20 that "(M.N.) improved over the past mo(nth) but not 100% resolved." No other notes or  
21 comments were made.

22           22.       In a note dated December 14, 2007 M.N. reported that she had a "partially  
23 detached retina." Further, Respondent reported that M.N. was bothered by bright light and "plans

24           <sup>1</sup> A laser is a light amplification by stimulated emission of radiation (LASER or laser) and  
25 is a mechanism for emitting electromagnetic radiation, typically light or visible light, via the  
26 process of stimulated emission. The emitted laser light is (usually) a spatially coherent, narrow  
27 low-divergence beam, that can be manipulated with lenses. In laser technology, "coherent light"  
28 denotes a light source that produces (emits) light of in-step waves of identical frequency and  
phase. Conceptual physics, Paul Hewitt, 2002.



1 to submit the bill to 2035, Inc., the Laser Manufacturer. Respondent wrote "use w/ eyes?  
2 Ophthalmologist?" Respondent added, "called my rep [ ] regarding speaking to M.N. or putting  
3 her in contact with manufacturer."

4 23. Lasers are not a modality listed for use by acupuncturists pursuant to Code section  
5 4937. Moreover, laser therapy is not taught in accredited schools of Chinese medicine.

6 24. Further, eye treatments are not common modalities for acupuncturists.

7 25. Respondent did not receive his training on the use of lasers through a Board  
8 approved continuing education course and, further, the manufacturer who provided Respondent  
9 with his training in the use of lasers is not an approved continuing education provider with the  
10 Board.

11 26. Respondent's August 17, 2007 and October 13, 2007 notes do not mention a  
12 treatment plan and/or course of treatment.

13 27. In acupuncture practice the standard of care for a practitioner is a Chinese medical  
14 diagnosis in accordance with the five elements, zang-fu, etc. Particularly in a case where a patient  
15 such as M.N. has a large number of complaints any treatment plan should include different  
16 modalities, acupuncture needling, heat application, moxibustion, herbal supplementation,  
17 nutritional counseling, and other treatments. There is no evidence that Respondent had such a  
18 treatment plan for M.N.

19 28. A licensed acupuncturist has both an ethical and legal obligation to protect his  
20 patient from unapproved treatment methods by his exercise of judgment. Acupuncturists have the  
21 obligation to assess the risks versus benefits of any untested treatment modality and further  
22 consult their peers of the same or similar professional interests if they believe that new methods  
23 may help their patients as an adjunctive therapy to standards of acupuncture practice:  
24 acupuncturists, the Acupuncture Board, medical practitioners among others. Further, there must  
25 be a level of mastery and competence a practitioner needs to have in order to perform any new  
26 techniques: One class typically does not constitute proficiency. Continued workshop training,  
27 certification, and/or working with a mentor are ways to develop a better understanding of the  
28

1 risks and benefits of the new modalities. Respondent failed to demonstrate such proficiency in his  
2 use of laser therapy.

3 29. In addition, Respondent's diagnosis does not support the use of laser therapy on  
4 patient M.N. His notes lack proper and thorough documentation concerning why laser therapy  
5 was necessary.

6 **CAUSES FOR DISCIPLINE**

7 **FIRST CAUSE FOR DISCIPLINE**

8 **(Unprofessional Conduct)**

9 30. Complainant repeats paragraphs 12 through 29 and incorporates same as if fully  
10 included herein.

11 31. Respondent engaged in general unprofessional conduct in his care and treatment of  
12 patient M.N., in violation of section 4655.

13 32. Respondent is subject to discipline accordingly.

14 **SECOND CAUSE FOR DISCIPLINE**

15 **(Failure to Register Place of Business with Board)**

16 33. Complainant repeats paragraphs 12 through 29 and incorporates same as if fully  
17 included herein. Respondent violated section 4961, subsection (a), when he failed to register his  
18 place of business, Hall Center, with the Board.

19 34. Although Respondent worked at the Hall Center from November 2005 to June  
20 2009 Respondent failed to list Hall Center as his place of practice with the Board.

21 35. Respondent is subject to discipline accordingly.


