
Pursuant to Penal Code section 23, Petitioner Benjamin Bodea, Acting Executive Officer of the Acupuncture Board, Department of Consumer Affairs (Petitioner), appeared on July 19, 2016, at 8:30 a.m., in Department N of the above-entitled court to make a recommendation to the Court that it issue an order prohibiting Defendant Wei Dong Zhao from practicing any aspect of

1 acupuncture pending the resolution of the above-captioned criminal matter. Petitioner appeared
2 through counsel, Kamala D. Harris, Attorney General of the State of California, by Wendy
3 Widlus, Deputy Attorney General. Defendant Wei Dong Zhao appeared and was represented by
4 counsel.

5 After considering the pleadings filed in connection with the Penal Code section 23
6 appearance and recommendation, hearing the arguments of counsel, and good cause appearing
7 therefore, it is hereby ordered that, as a condition of any bail, own recognizance release, or
8 probation, Defendant Wei Dong Zhao is hereby prohibited from practicing any aspect of
9 acupuncture until final disposition of the criminal charges pending against him in Los Angeles
10 Superior Court Case No. KA112335.
