# **ACTIVE / INACTIVE LICENSE APPLICATION**

## Instructions and Advisements

## Active / Inactive license request procedures:

- 1. Please be sure you signed and dated at the bottom.
- 2. If going back to active status you do not need to list CE credits. Save the certificates for 4 years in case you are chosen for a CE audit.
- 3. Submit a check or money order for \$50 to get a new pocket license when requesting to return to active status only.
- 4. Check your updated status on the Acupuncture Board website. Applications may take 1 week to process once received by the Board.

#### LAWS and REGULATIONS PERTAINING TO ACTIVE / INACTIVE LICENSURE

#### CA Business and Professions Code section 701

(b) Each healing arts board referred to in this division shall issue, upon application and payment of the normal renewal fee, an inactive license or certificate to a current holder of an active license or certificate whose license or certificate is not suspended, revoked, or otherwise punitively restricted by that board.

## California Code of Regulations – Title 16, Chapter 13.7

#### §1399.489.1

- (a) Any licensee who is not actively engaged in the practice of acupuncture desiring an inactive license under the provisions of Article 9 (commencing with Section 700) Chapter 1 of Division 2 of the code or to restore an inactive license to active status shall submit a completed "Active/Inactive License Application"), that is hereby incorporated by reference, to the board. The applicant need not submit his or her certificate or a copy thereof to the board with the application.
- (b) To restore an inactive license to active status, the licensee shall have completed a minimum of 50 hours of approved continuing education within the last two (2) years in compliance with this article. At least 45 hours of continuing education must be in coursework approved as Category 1. In the event a license has been inactive less than one (1) year, a minimum of 25 hours of continuing education is required, with at least 22.5 hours of coursework approved as Category 1, and four (4) hours in law and ethics.
- (c) The inactive status of any license shall not deprive the board of its authority to institute or continue a disciplinary proceeding against a licensee upon any ground provided by law or to enter an order suspending or revoking a license or otherwise taking disciplinary action against the licensee on any such ground.
