### Acupuncture Board – Addendum to Responses to the Background Paper

This addendum is provided to the Committees to further address the questions that Senator Pan and Assemblymember Gipson asked during the Board's Sunset Hearing regarding the Board's Enforcement Performance Measures, including, the violations the Board receives separated by type as well as how the Board addresses public safety for more egregious violations.

## **Cases Closed without Disciplinary Referral**

In looking at the Board's Enforcement statistics over the last four fiscal years for cases closed without referral for discipline, the overall trend shows a decrease in the intake and investigation time for every violation type. However, please note that if there were no cases closed for a violation type during a fiscal year, then no data exists for comparative purposes. Graph I also illustrates this downward trend from 2013/14 to 2016/17 with all lines depicting a sloped high to low linear pattern. The Board's overall average performance measure target for cases closed without referral for discipline is 200 days. The Board's overall average for this performance measure was 376 days in 2013/14 and decreased to 149 days in 2016/17.

When the statistics are broken down further by violation type, the following changes are observed after comparing 2013/14 and 2016/17:

The tables in Exhibit A show the actual number of days to process complaints from receipt of complaint to the closure of the complaint. In looking at the violation types with the highest number of days to process across all fiscal years, the more complex cases can be pinpointed. The two violation types that consistently have higher days to process in all four fiscal years are Fraud and Incompetence/Negligence cases. These two violation types typically require formal investigations conducted by Division of Investigation (DOI) and will often require a secondary review by Subject Matter Experts contracted out by the Board. Another complexity involved with these types of cases is

the gathering of patient records, usually obtained from several different practitioners or insurance companies. Additionally, since Fraud is also a criminal offense that carries a higher burden of proof, investigations can be lengthened to obtain the necessary evidence. Evidence gathered for these types of cases to go on for criminal and administrative prosecution not only must meet a clear and convincing burden of proof, but also the violation must be proven beyond a reasonable doubt. Since these cases were not referred for discipline, these burdens were not met. Even though the same investigative intent and plan are followed, sometimes a departure from the standard and a violation of the laws and regulations is not substantiated.

Further, a certain percentage of cases categorized as Incompetence/Negligence originate as malpractice settlements or judgments reported to the Board. Given the terms of malpractice settlements, it is sometimes problematic to gain the cooperation of patients to obtain the necessary medical records for a complete investigation. These hurdles also lengthen the timeline.

## **Cases Closed with Disciplinary Referral**

The Board's Enforcement statistics over the last four fiscal years for cases closed with referral for discipline show overall decreases in the intake and investigation time for the violation types with data. Given the small volume of cases that result in formal discipline each fiscal year, no data exists in six of the violation types, and one violation type does not have any previous fiscal year data for comparative purposes. The data that does exist, which is illustrated in graph II, does not depict the same true linear decline. However, when one looks at the change in days from prior fiscal years to 2016/17 broken out in more detail, there is a decrease in each violation type.

The Board's overall average performance measure target for cases closed with referral for discipline is 540 days. The Board's overall average for this performance measure was 1,004 days in 2013/14 and decreased to 774 days in 2016/17.

Exhibit B shows Unprofessional Conduct as the highest number of days to process in three of the four fiscal years. Since Unprofessional Conduct is such a broad violation category, the complexities vary. In addition, the cases that go on for discipline typically have more than one violation type charged. For example, by the time a complaint is investigated and reviewed by a Subject Matter Expert, there can be findings that support general unprofessional conduct, negligence, and fraud. When a complaint

comes into intake and is assigned a violation type, there is only one category that can be selected in the database. Further, when a complaint comes in alleging several different violations, unprofessional conduct is typically assigned because when any violation of the Acupuncture Licensure Act occurs, it is considered unprofessional conduct in addition to any other violations that may exist. Due to complaints alleging numerous violations, the investigations and review of these different claims can be lengthier and more complex.

Although the Board is faced with complexities in investigating cases that can lengthen the timeline, there are authorities in place that allow the Board to obtain public protection at a more rapid pace. Penal Code section 23 authorizes the Board to appear during a criminal proceeding and request license suspension or recommend that the court impose a condition of bail or probationary terms to protect the interests of the public. Knowing the Board has such an authority, arrests and criminal charges are reviewed and a determination is made on whether the incident poses any immediate harm to the public. If there is concern, the Board can refer the case to the Office of the Attorney General to represent the Board and appear at the criminal proceeding on a Penal Code section 23 request. These are typically done in cases involving violence or sexual assault to a patient, but can also be pursued on cases such as egregious fraud charges.

Additionally, when the Board receives a consumer complaint with allegations that pose an immediate danger to the public health, safety or welfare, these cases are assigned an urgent priority. The Board also requests that DOI expedite the investigation of these cases. Once the investigations and reviews are complete and a decision to refer for discipline has been made, a request for an Interim Suspension Order can be pursued. An Interim Suspension Order is used to suspend a licensee from the practice of acupuncture during the pendency of an administrative disciplinary process. The Administrative Law Judge is tasked with granting or denying the Interim Suspension Order. Once an Interim Suspension Order is granted, the disciplinary process is fasttracked to achieve long-term public protection at a quicker rate.

### **Current Fiscal Year 2017/18**


The current fiscal year shows large strides in the reduction of days to process cases in the first two quarters, especially focusing on cases referred for discipline. In quarter one, the overall average number of days to process discipline was 482 days and in quarter two it was 479 days. This is a great improvement that shows the Board has met the target of 540 days over a six-month period. This single measure is a great indicator of how the Board's Enforcement program is improving with each fiscal year.


