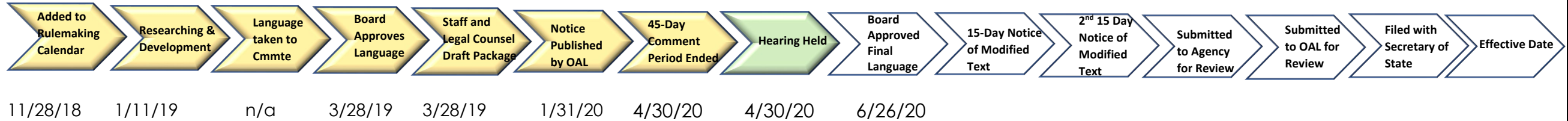

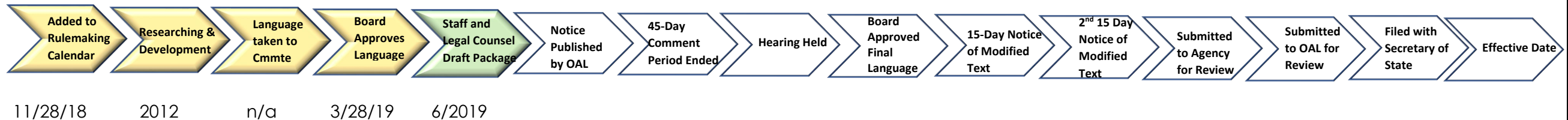
AB 2138: Denial of Application, Revocation or Suspension of Licensure for a Criminal Conviction

SB 1441: Implement Uniform Standards Related to Substance Abusing Licensees and Update of Disciplinary Guidelines

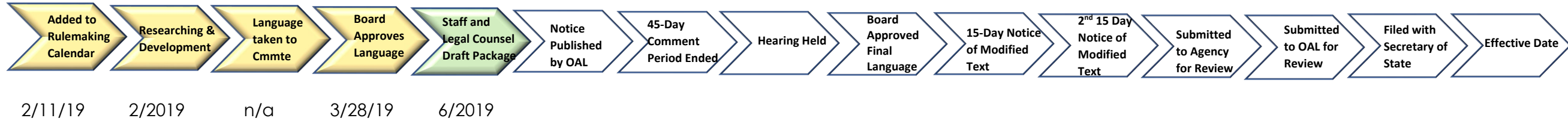

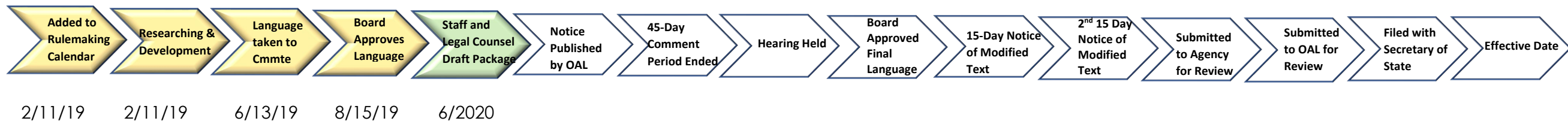
SB 1448: Disclosure of Probation Status to Patients
