#### **CONTINGENCY**

11. The parties agree that this Stipulated Settlement and Disciplinary Order shall be submitted to the Board for its consideration in the above-entitled matter and, further, that the Board shall have a reasonable period of time in which to consider and act on this Stipulated Settlement and Disciplinary Order after receiving it. By signing this stipulation, Respondent fully understands and agrees that he may not withdraw his agreement or seek to rescind this stipulation prior to the time that the Board considers and acts upon it.

The parties agree that this Stipulated Settlement and Disciplinary Order shall be null 12. 8 and void and not binding upon the parties unless approved and adopted by the Board, except for 9 this paragraph, which shall remain in full force and effect. Respondent fully understands and 10 agrees that in deciding whether or not to approve and adopt this Stipulated Settlement and 11 Disciplinary Order, the Board may receive oral and written communication from its staff and/or 12 the Attorney General's Office. Communications pursuant to this paragraph shall not disqualify 13 the Board, any member thereof, and/or any other person from future participation in this or any 14 other matter affecting or involving Respondent. In the event that the Board, in its discretion, does 15 not approve and adopt this Stipulated Settlement and Disciplinary Order, with the exception of 16 this paragraph, it shall not become effective, shall be of no evidentiary value whatsoever, and 17 shall not be relied upon or introduced in any disciplinary action by either party hereto. 18 Respondent further agrees that should the Board reject this Stipulated Settlement and Disciplinary 19 Order for any reason, Respondent will assert no claim that the Board, or any member thereof, was 20 prejudiced by its/his/her review, discussion and/or consideration of this Stipulated Settlement and 21 Disciplinary Order or of any matter or matters related hereto. 22

## **DISCIPLINARY ORDER**

3

IT IS HEREBY ORDERED that Acupuncture License No. AC 15888 issued to Respondent
Seung Man Yu is revoked. However, the revocation is stayed and Respondent is placed on
probation for three (3) years on the following terms and conditions.

- 1. <u>ALCOHOL AND DRUG ABUSE TREATMENT</u>:
- 28

Effective 30 days from the date of this decision, Respondent shall commence attending Twelve-Step meetings or the equivalent, as approved by the Board. Attendance shall be at least three (3) times per week during the first year of probation. Proof of attendance at these meetings must be submitted quarterly to the Board. Failure to attend the meetings or to timely submit proof of attendance will be considered a violation of probation.

# 2. <u>ABSTAIN FROM DRUGS AND ALCOHOL AND SUBMIT TO TESTS AND</u> <u>SAMPLES</u>:

Respondent shall abstain completely from the personal use or possession of controlled 8 substances as defined in the California Uniform Controlled Substances Act (Division 10, 9 commencing with section 11000 of the Health and Safety Code) and dangerous drugs as defined 10 by Section 4022 of the Business and Professions Code, or any drugs requiring a prescription. 11 Respondent shall abstain completely from the use of alcoholic beverages. Respondent shall 12 undergo random, biological fluid testing, as determined by the Board. Respondent shall bear all 13 costs of such testing. The length of time and frequency will be determined by the Board. Any 14 confirmed positive finding will be considered a violation of probation. 15

# 3. <u>COURSEWORK</u>:

Respondent shall take and successfully complete not less than eight (8) hours of 17 coursework in the following area: Ethics. The coursework shall be taken as approved by the 18 Board. Classroom attendance must be specifically required. Course content shall be pertinent to 19 the violation and all coursework must be completed within the first two (2) years of probation. 20 The required coursework must be in addition to any continuing education courses that may be 21 required for license renewal. Within ninety (90) days of the effective date of the Decision, 22 Respondent shall submit a plan for the Board's prior approval for meeting the educational 23 requirement. All costs of the coursework shall be borne by the Respondent. 24

# COMMUNITY SERVICE:

Respondent shall perform 100 hours of community service. The services rendered shall be professional in nature and under the auspices of a governmental entity or a non-profit corporation that is tax exempt under the Internal Revenue Code. Within sixty (60) days of the effective date

of this decision, Respondent shall submit to the Board for its prior approval a community service 1 plan. Prior to engaging in the community service, Respondent shall provide a copy of the 2 decision in this matter to the manager, director or other person in charge of the organization 3 (Decision Maker) where this service will be performed. Within fifteen (15) days of providing the 4 documentation to the Decision Maker, as required, Respondent shall submit written proof of 5 compliance to the Acupuncture Board. In no event shall such proof be provided later than two (2) 6 weeks after having engaged in the community service. Additionally, Respondent shall have the 7 manager, director, or other person in charge of the organization submit confirmation directly to 8 the Board when Respondent has completed the 100 hours of community service required by this 9 10 agreement. 5. **OBEY ALL LAWS:** 11 Respondent shall obey all federal, state and local laws and all regulations governing the 12

practice of acupuncture in California. A full and detailed account of any and all violations of law
shall be reported by Respondent to the Board in writing within seventy-two (72) hours of
occurrence.

#### **QUARTERLY REPORTS**:

17 Respondent shall submit quarterly declarations under penalty of perjury on forms provided
18 by the Board, stating whether there has been compliance with all the conditions of probation.

#### 7. SURVEILLANCE PROGRAM:

Respondent shall comply with the Board's probation surveillance program and shall, upon 20 reasonable notice, report to the assigned investigative district office. Respondent shall contact the 21 assigned probation surveillance monitor regarding any questions specific to the probation order. 22 Respondent shall not have any unsolicited or unapproved contact with 1) victims or complainants 23 associated with the case outside of that contact permitted by the Santa Clara County Superior 24 Court in the matter People of the State of California v. Seungman Yu, Superior Court Case No. 25 C1501715; 2) Board members or members of its staff; or 3) persons serving the Board as expert 26 examiners. 27

#### 8. <u>INTERVIEW WITH THE BOARD OR ITS DESIGNEE</u>:

## CHANGES OF EMPLOYMENT:

Respondent shall notify the Board in writing, through the assigned probation surveillance
compliance officer of any and all changes of employment, location and address within thirty (30)
days of such change.

# TOLLING FOR OUT-OF-STATE PRACTICE OR RESIDENCE:

8 In the event Respondent should leave California to reside or to practice outside the State,
9 Respondent must notify the Board in writing of the dates of departure and return. Periods of
10 residency or practice outside California will not apply to the reduction of this probationary period.

# 11. <u>EMPLOYMENT AND SUPERVISION OF TRAINEES</u>:

Respondent shall not employ or supervise or apply to employ or supervise acupuncture
trainees during the course of this probation. Respondent shall terminate any such supervisorial
relationship in existence on the effective date of this probation.

## 12. <u>COST RECOVERY</u>:

Respondent shall pay to the Board its costs of investigation and prosecutorial costs incurred by the Board in the amount of \$1827.25. Respondent shall be permitted to pay these costs in a payment plan approved by the Board, with payments to be completed no later than six months prior to the end of the probation term. Cost recovery will not be tolled. Respondent understands that failure to make payments in accordance with any formal agreement entered into with the Board or pursuant to any Decision by the Board shall be considered a violation of probation.

## 13. <u>VIOLATION OF PROBATION</u>:

If Respondent violates probation in any respect, the Board may, after giving Respondent notice and the opportunity to be heard, revoke probation and carry out the disciplinary order that was stated. If an accusation or petition to revoke probation is filed against Respondent during probation, the Board shall have continuing jurisdiction until the matter is final, and the period of probation shall be extended until the matter is final. No petition for modification or termination
