**STIPULATED SURRENDER OF
LICENSE AND ORDER**

19 **IT IS HEREBY STIPULATED AND AGREED** by and between the parties to the above-
20 entitled proceedings that the following matters are true:

21 **PARTIES**

22 1. Benjamin Bodea (Complainant) is the Executive Officer of the Acupuncture Board
23 (Board). He brought this action solely in his official capacity and is represented in this matter by
24 Xavier Becerra, Attorney General of the State of California, by Wendy Widlus, Deputy Attorney
25 General.

26 2. Chien-Liang Lin, L.Ac. (Respondent) is represented in this proceeding by attorney
27 Ronald Talmo, Esq., whose address is: 1202 S. Ross Street, Santa Ana, CA 92707.

28 3. On or about September 26, 2000, the Board issued Acupuncturist License No. AC

1 7526 to Chien-Liang Lin, L.Ac. (Respondent). The Acupuncturist License was in full force and
2 effect at all times relevant to the charges brought in the First Amended Accusation No. 1A-2014-
3 31 and will expire on December 31, 2019, unless renewed.

4 **JURISDICTION**

5 4. The First Amended Accusation No. 1A-2014-31 was filed before the Board, and is
6 currently pending against Respondent. The First Amended Accusation and all other statutorily
7 required documents were properly served on Respondent on August 6, 2019. Respondent timely
8 filed his Notice of Defense contesting the First Amended Accusation. A copy of the First
9 Amended Accusation No. 1A-2014-31 is attached as Exhibit A and incorporated by reference.

10 **ADVISEMENT AND WAIVERS**

11 5. Respondent has carefully read, fully discussed with counsel, and understands the
12 charges and allegations in the First Amended Accusation No. 1A-2014-31. Respondent also has
13 carefully read, fully discussed with counsel, and understands the effects of this Stipulated
14 Surrender of License and Order.

15 6. Respondent is fully aware of his legal rights in this matter, including the right to a
16 hearing on the charges and allegations in the First Amended Accusation; the right to confront and
17 cross-examine the witnesses against him; the right to present evidence and to testify on his own
18 behalf; the right to the issuance of subpoenas to compel the attendance of witnesses and the
19 production of documents; the right to reconsideration and court review of an adverse decision;
20 and all other rights accorded by the California Administrative Procedure Act and other applicable
21 laws.

22 7. Respondent voluntarily, knowingly, and intelligently waives and gives up each and
23 every right set forth above.

24 **CULPABILITY**

25 8. Respondent understands that the charges and allegations in the First Amended
26 Accusation No. 1A-2014-31, if proven at a hearing, constitute cause for imposing discipline upon
27 his Acupuncturist License.

1 copies of this Stipulated Surrender of License and Order shall have the same force and effect as
2 the originals.

3 15. In consideration of the foregoing admissions and stipulations, the parties agree that
4 the Board may, without further notice or formal proceeding, issue and enter the following Order:

5 **ORDER**

6 **IT IS HEREBY ORDERED** that Acupuncturist License No. AC 7526, issued to
7 Respondent Chien-Liang Lin, L.Ac., is surrendered and accepted by the Board.

8 1. The surrender of Respondent's Acupuncturist License and the acceptance of the
9 surrendered license by the Board shall constitute the imposition of discipline against Respondent.
10 This stipulation constitutes a record of the discipline and shall become a part of Respondent's
11 license history with the Board.

12 2. Respondent shall lose all rights and privileges as an Acupuncturist in California as of
13 the effective date of the Board's Decision and Order.

14 3. Respondent shall cause to be delivered to the Board his pocket license and, if one was
15 issued, his wall certificate on or before the effective date of the Decision and Order.

16 4. If Respondent ever files an application for licensure or a petition for reinstatement in
17 the State of California, the Board shall treat it as a petition for reinstatement. Respondent must
18 comply with all the laws, regulations and procedures for reinstatement of a revoked or
19 surrendered license in effect at the time the petition is filed, and all of the charges and allegations
20 contained in the First Amended Accusation No. 1A-2014-31 shall be deemed to be true, correct
21 and admitted by Respondent when the Board determines whether to grant or deny the petition.

22 5. Respondent shall pay the agency its costs of investigation and enforcement in the
23 amount of \$39,273.50 prior to Respondent submitting a petition for reinstatement of his license.

24 6. If Respondent should ever apply or reapply for a new license or certification, or
25 petition for reinstatement of a license, by any other health care licensing agency in the State of
26 California, all of the charges and allegations contained in the First Amended Accusation, No. 1A-
27 2014-31 shall be deemed to be true, correct, and admitted by Respondent for the purpose of any
28 Statement of Issues or any other proceeding seeking to deny or restrict licensure.
